- 1. **Meeting was called to order** by Chair Ken Linsley at 6:00 pm.
- 2. Additions to the agenda:

- 3. Motion by Kellie Merrell, 2nd by Henry Pearl to approve **minutes** of **Regular meeting** of **February 6, 2020** with changes to page 3. Vote 5-0-0. All in favor.
- 4. Visitors
 - Walter McNeil, Jr. NEKWMD (Northeast Kingdom Waste Management District) discussed:
 - Residential food waste (Act 148). Fast Trash Hauler has to provide residential food waste pick up. There are two places in Danville, Queen of Peace Church and Martys First Stop where a Fast Trash Hauler can be found. July 1, 2020 all food scraps cannot go into landfills. The Town of Danville does not have to do anything for residential food waste pick up as it is the responsibility of the hauler.
 - Board meeting update. The Host Agreement with the Town of Lyndon was discussed. The VT Department of Taxes has not given the Town of Lyndon a written legal opinion of whether the NEKWMD property is taxable or not. NEKWMD board's legal counsel is going to draft a letter to the Town of Lyndon.
 - Conservation Commission Town Forest Timber sale notice and prospectus

Wes Everts spoke of timber sale on Rodgers Lot. Harvest details, criteria for loggers (LEAP Certificate and No AMP Violations), hiring someone from Danville, and bid process was discussed. An invitation to bid will be sent out and bids are asked to be returned by May 15th. Public outreach will be done before, during and after the harvest as the Conservation Commission wants the public to be well informed of the on goings.

Vange Morse discussed Matt Langlais' recommendation for a marking amendment to the Management Plan regarding four stands.

Dave Houston discussed monies and use.

Keith Gadapee discussed wood dump area.

Selectboard is to review and address any concerns with the Town Forest Timber Sale Notice and Prospectus at their next meeting.

Motion by Eric Bach, 2nd by Henry Pearl to approve changes recommended by Matt Langlais to the Management Plan for the Town Forest for four stands identified and for Ken Linsley to sign the agreement. Vote 5-0-0. All in favor.

6. **Highway Foreman** (Keith Gadapee)

Posting of Class 3 Roads for mud season – the town has not posted in the past.

Consensus is not to post but to deal with individuals as necessary.

Paving Grant – Keith Gadapee did not put in any revenue for a paving grant through VTrans. The thought
was the Town may or may not get the money even if the Town applied.

Consensus is for Keith Gadapee to apply for Paving Grant through VTrans.

 V2V (Village to Village) group is promoting rail trail. They received an email offering signs to be placed along Route 2 to promote the use of the Rail Trail. The signs show places around Town where to park for bike parking and/or snowmobile parking. The group has discussed locations such as Joe's Pond Beach and areas owned by local business persons.

(a) Bid Opening - 10 Wheel

Henry Pearl noted that Craig Morris (not in attendance) has requested that he suggest to the Selectboard members on behalf of Craig Morris to get a bid for used non emissions truck and manual transmission.

Kate Whitehead will come before the Selectboard on April 16th with an update. On April 26th a Community Meeting will be held at Town Hall.
