General Updates

Train Station Subcommittee

Chimney stabilization work has been done. Looking at applying for a USDA – Rural Business Development Grant for feasibility study re: market research & draft architectural conceptual designs for potential uses. NVDA reaching out to consultants for cost estimates. Match not required, but will make application more competitive. Preservation Trust of VT Sincerbeaux Grant to fund building assessment study – requires a \$250 match. Looking into 501c3 status for Train Station Committee. Determination of Eligibility for Historic Register has been submitted.

Train Station Committee Charter Review & Update

Add language to section D # 2 (agenda & meeting notices) – about meeting places/required postings. Michael proposed new language for section C #5 (organization) of the charter to allow for working group discussions between regular scheduled monthly meetings w/groups reporting back to committee during regular monthly meetings.

MOTION: Glenn Herrin made a motion to authorize Glenn Herrin to make changes to the Train Station Charter. Vince Foy seconded. Motion Carried.

Zoning Administrator Position/Nomination

Zoning Bylaw – Draft Editing

PC continued through NVDA comments & questions: discussed definitions for dwelling accessories, home childcare, light industry, travel trailer vs recreation vehicle. Added language to

603.1 non-conforming structures re: structures outside of flood hazard area. Added language to 804.2 include "VTrans highway access permit if project requires site plan review".

MOTION: Glenn Herrin made a motion to authorize Jenni Lavoie to make any required formatting and grammar changes to the zoning bylaws for submission to the Selectboard. Jeff Paquet seconded. Motion carried.
